Do you qualify for the Earned Income Tax Credit?

You do if you earn less than...

- **\$38,646** and have more than one qualifying child
(**\$41,646** if married and filing jointly)
- **\$33,995** and have one qualifying child
(**\$36,995** if married and filing jointly)
- **\$12,880** and have no children
(**\$15,880** if married and filing jointly)

YOUR REFUND MAY BE AS MUCH AS:

- ➔ **\$4,824** if you have more than one qualifying child;
 - ➔ **\$2,917** if you have one qualifying child; or
 - ➔ **\$ 438** if you have no children

Required Items for Completing an Accurate Return

- Proof of identification for yourself and/or your spouse
- Social Security Cards for all individuals in household
- Individual Tax Identification Number (ITIN) Verification letter issued by the Internal Revenue Service (IRS)
- Birth dates for all individuals in household
- Wage and earning statement(s) from all employers (**Forms W-2, W-2G, 1099-R**)
- Interest and dividend statement from banks (**Form 1099**)
- Bank routing numbers and account numbers for direct deposit
- Other relevant information about income and expenses
- Total amount paid for day care and the day care providers' Tax Identification Number (the individual's social security number or the business' Employer Identification Number)
